ONE YEAR LIMITED WARRANTY FOR DELIVERED CONCRETE

ONE YEAR LIMITED WARRANTY- Subject to the guidelines of the Stamm Contracting Co., Inc. (Company) Limited Warranty set forth herein, the Company pledges to its customers that all concrete and grout materials manufactured by the Company will be free of defects and will perform for a period of one year from the day of delivery. Limited Exclusive Remedy- *This warranty is limited to replacement of the concrete products.* Notification & First Opportunity to Correct Required- Within ten (10) days of the first knowledge of any defect the Company is to be notified, in writing, of the defect by the Customer. The Company shall be given first opportunity to replace the concrete products found to be defective in a timely manner at no cost for the product to the owner. Under no circumstances shall Stamm Contracting Co., Inc. be liable for indirect, secondary or consequential damage of any nature arising out of the use or inability to use any or part of this product or for personal injury. Matters Not Covered & Waiver- Damage from salt, chemicals, normal wear and tear, mechanical equipment, vehicles, misuse or abuse, earthquake, soil movement, storms, accidents, acts of God and other things out of Company's control are not covered. This Warranty does NOT apply to: concrete to which additional water was added to the mix at the instruction of the customer, contractor or any representative of same; **any product not manufactured by the Company (Customers should check product warnings, warranties and use & safety instructions before using any product.)**; any construction work that has been modified, altered, defaced and/or had repairs made/attempted by others; cracks in the concrete under any circumstances; or, spalls (disintegration) or scaling that affects the appearance of the concrete unless the condition is significant and exists in more than 10% of any panel. The **color** of concrete after it is finished and cured **is not guaranteed** or otherwise covered by any warranty.

THIS LIMITED WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED. THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR PARTICULAR PURPOSE ARE SPECIFICALLY EXCLUDED.

WARNING - CARE INSTRUCTIONS: USING SALTS OR DEICERS ON CONCRETE ACCELERATES THE DETERIORATION OF CONCRETE THROUGH THE FREEZE/THAW EFFECT AND CHEMICAL REACTIONS. USING SALTS OR DEICERS ON CONCRETE DURING THE FIRST YEAR AFTER PLACEMENT IS ESPECIALLY DAMAGING AND MAY RESULT IN SPALLING AND/OR SCALING, WHICH DAMAGE IS NOT COVERED BY THE STAMM CONTRACTING CO., INC.
